## People urged to have a say on budget

We are asking people to have their say on how our Council has balanced its budget amid continuing financial pressures.

The Council initially faced a predicted budget shortfall of almost £60 million for the next financial year due to a range of factors including high inflation, which is driving up running costs, and a significant increase in service demand.

Our Cabinet has proposed a range of saving and efficiency proposals which will allow the Council to meet that shortfall, while protecting vital frontline services, including:

- Increasing fees and charges for services such as garden waste collections and car parking, aligning them with the national average to fairly reflect today's operating costs, and allowing the Council to meet the demand in critical services protecting vulnerable adults and children.
- Reviewing services to make them more efficient while saving hundreds of thousands of pounds. The proposals include reviewing the policy, processes and systems for the Home to School Transport service to reduce running costs, and the introduction of three-weekly bin collections in South Northants and some parts of Northampton, to bring it in line with the Daventry area.
- Raising Council Tax by 4.99%, in line with the Government's allowance, generating additional funding of around £11.5 million - with 2% of the increase going towards adult social care.
- Restructuring service areas within the organisation and introducing new, more efficient ways of working to make back office savings without impacting on how services are delivered to residents.
- Investing significant extra funding to meet the increasing demand for adult and children's services, providing more cost effective and better preventative care for vulnerable residents.

During the next financial year we plan to carry out a capital investment programme of more than £12.2 million to improve local roads, and public health funding will be used to improve residents' wellbeing, reduce health inequalities and support communities through this period of high inflation.

We will also continue to drive economic growth in West Northants, with further progress expected on the multi-million-pound regeneration of Northampton through the Government's Towns Fund.

The challenge of bridging the £60 million funding gap left us with some very tough decisions, so we have produced a set of proposals that address the pressures we are under, while allowing us to continue to protect the most vulnerable in our society, and deliver services to residents across our communities.

# Exceeding transformation target for taxpayers

I am proud of the good progress we have made in our first two years towards transforming and improving public services for our residents, so it is great to see that we are on course to exceed our targets for making efficiencies and savings, as part of the local government reform programme.

A [report which went before our Cabinet in December](#) highlighted how our new unitary authority has exceeded the original savings target we inherited when replacing the former Daventry, Northampton, South Northants and County councils on 1 April 2021.

Savings of £84m were estimated from merging the eight councils across Northamptonshire into two new single-tier authorities, with £49m of these delivered before the abolition of the legacy councils prior to vesting day.

This left our Council and our neighbouring new authority North Northants Council a requirement to deliver the remaining savings of £17.5m each in our first few years.

The figures shared at the Cabinet meeting show we are on course to have exceeded these savings by the end of 2025/26, including an additional £16.4m as part of the transformation journey to bring together and improve services from the four legacy councils.

Since being established less than two years ago the Council has faced significant challenges, bringing together multiple systems, processes, service functions and finances across 3,000 staff, 800 systems, four main office buildings and thousands of inherited contracts. Ongoing work to transform and improve services, as well as identifying savings and efficiencies, is based around the following themes:

- Looking at where services can be reorganised or shared and internal departments working more closely together to reduce resource and operating costs and improve service
- Investing in 'preventative' services to reduce or slow demand for other services and reduce costs
- Exploring ways of buying services differently and reviewing and combining contracts from the legacy councils to save money
- Aligning fees and charges originally set by the old councils, generating new income streams and accessing external grants and funding
- Bringing IT systems together and using digital innovation and automation to reduce service costs
- Centralising back office systems and processes to making them more efficient, benchmarking them against best practice and looking at national policies that enable the capitalisation of costs or use of grants.

We know there is still more work to do, and this is all being done against the backdrop of continued challenges around the cost of living, inflation, and financial pressures resulting from the rise in demand for services. However we have made a strong start, as we continue to build upon our clear vision for making West Northants a great place to live, work, visit and thrive.



## Police, fire and crime budget consultation

The Northamptonshire Police, Fire and Crime Commissioner Stephen Mold has launched a consultation on the level of council tax precept for policing and fire and rescue services in the county next year

For policing, there is a proposed increase of £15 a year for an average Band D household – 5.3% or 29p a week. For fire and rescue, the proposed increased is £5 a year for an average Band D household – 7.3% or 10p a week. People can have their say until 4pm on 17 January by [completing the online survey](#)

# Bus fares reduced as part of national scheme

Many bus fares across West Northamptonshire are being reduced for the first three months of this year as part of a Government's scheme to provide more affordable public transport.

Operators including Stagecoach and Uno have capped single fares at £2 from this month through to the end of the March.

This will mean a reduction of more than 60 per cent in the cost of the fare on the longest routes.

The scheme seeks to get more people to travel by buses and help to reduce emissions by taking an estimated 2 million cars off the roads during this period.

We welcome this initiative in West Northamptonshire, and hope that it will encourage more people across the area to make the most of bus services during the first three months of 2023 at this fantastically reduced rate.

At a time when costs are impacted by inflation, the bus industry has faced a challenging time.

Not only will the discounted fares enable people to save money it will help to reduce emissions across the area, supporting our objective of West Northants becoming net zero.

# Survey seeks to review support for carers

Our Council is working with the NHS, North Northamptonshire Council and voluntary sector organisations to support carers of people with a learning disability and/or autism in a more joined-up way.

To do this, feedback is sought from carers to understand the service provision needed to better meet the needs of those with a learning disability and/or Autism, to help shape future plans for services going forwards.

The survey asks unpaid carers in Northamptonshire with lived experience of caring for a loved-one with a learning disability and/or autism to share their views on what support they feel they need or what would help carers planning in the future.

It is really important that we hear people's views to ensure we better understand needs and highlight opportunities for more integrated ways of working between services and organisations.

# Fly-tipping scheme to help private landowners

We would like to call on Town and Parish Councils to help us raise the profile of a funding scheme to help private landowners tackle fly-tipping.



As you will be aware, when fly-tipping takes place on public land, the taxpayer pays for the removal and disposal of the waste. However, if a fly-tip occurs on private land, the landowner pays for the clean-up and removal.

Under this scheme, landowners across West Northamptonshire can apply for funding to clear and prevent fly-tipping on their land.

The scheme was initially launched as a pilot last year by Stephen Mold, the Police, Fire, and Crime Commissioner for Northamptonshire, and was extended in October for a further 12 months.

Private landowners are able to apply for a grant of up to £1,500 towards the cost of having the fly-tipped waste cleared away and to support them in establishing prevention measures which will make the land less vulnerable to fly-tippers in the future. Funding is only available for private landowners who are unable to access other sources of public funding.

Town and Parish Councils are not eligible to receive funding, however I would like to encourage you to share information about this funding with private landowners in your local area.

# New Partnership will help with event planning

Is your council planning an event this year? Please ensure you make good use of the Event Safety Partnership (ESP), set up by our Council in consultation with colleagues at the police, fire and rescue and East Midlands Ambulance Service.

The ESP receives applications for events on behalf of all partners and deposits the information on Resilience Direct – a secure repository that blue light services and selected Council colleagues can access.

Our Council has a duty of care to ensure that any events held on our land are compliant with current legislation but above all are safe and legal. Any event that is not on our land but in the WNC catchment area will still be subject to scrutiny from partners, for example:

- Northamptonshire Fire and Rescue service will want to see a risk assessment for anything fire or firework related
- Environmental Health will want to inspect catering outlets, inflatables and fairground rides
- Licensing will ensure people have the correct licensing arrangements in place
- The police joint operation team will want to know about large gatherings of people so they can allocate resource effectively

The ESP is also able to advise on anything event related, so groups planning an event can be provided with templates and guidance for event management plans, risk assessments, food safety, inflatables, counter terrorism and more.

# Further advice to keep winter illnesses at bay



Residents are being urged to take some simple yet crucial steps to protect themselves, families and friends from an increased risk of flu, Covid-19 and Scarlet Fever currently circulating communities across Northamptonshire.

Winter illnesses are continuing to spread countywide following the Christmas break, with local health services under significant pressure due to a rising demand for emergency care.

Public Health officials at West and North Northamptonshire Councils are encouraging residents to follow national health guidance help reduce the risk of infection by taking the following steps:

- They may seem obvious, but the simplest, most effective ways to avoid catching and spreading viruses is regular handwashing and covering your nose or mouth when you sneeze or cough. [Wash hands thoroughly](#) with soap using running water then dry them.
- If your child is unwell and has a fever, you are advised to keep them at home until the fever has passed and they feel better. During this time your child should avoid attending school, nursery, a childminder or having contact with any other person outside the household.
- If you are feeling unwell and have a high temperature and do not feel well enough to carry out normal activities, try to stay at home and avoid contact with other people, until you no longer have a high temperature (if you had one) or until you no longer feel unwell.
- If you have been asked to attend a hospital, GP or dental appointment in person, contact your healthcare provider and let them know about your symptoms before attending. Please do not attend a high-risk setting such as a care home or nursing home until you no longer feel unwell.
- If a person needs to leave the house whilst they are unwell, UKHSA recommends a face covering is worn at all times to help reduce the spread of infections. Read further [advice on the guidance for people with symptoms of a respiratory infection or a positive test result](#)
- Vaccination is the best protection against any avoidable illness such as [Flu](#) or [COVID-19](#) and residents are strongly encouraged to get vaccinated if eligible. Children are also eligible for a free flu vaccination including those aged 2 and 3 (*on 31 August 2022*), all primary school-aged children and some secondary school-aged children. # Council successful in securing £5.4m funding

Our Council has been granted more than £5.4m in funding from the Government to boost the local economy over the next three years.

The funding, provided by the UK Shared Prosperity Fund (UKSPF), is the largest allocation in the South East Midlands and will be used to improve people's life chances, increase skills, create stronger communities, and support local businesses.

We [submitted our investment plan back in September](#) and this was subject to a robust consultation process which involved engaging with stakeholders to identify priority areas that would benefit most from a share of the funding.

Some expected outcomes from the funding include:

- New and improved cycleways and paths, resulting in increased active travel
- Funding for volunteer and social action projects
- Measures to reduce the cost of living, improve energy efficiency, and combat fuel poverty and climate change
- Decarbonisation and improving the natural environment
- Support for new business start-ups and continued support at all stages of development
- Driving employment growth, with tailored support and training to help people into work.

An additional £1.9m has been secured as multiply funding, which is specifically targeted at improving adult numeracy to advance people's chances of progressing their careers.

We have also been allocated a further £1.367m from the Government under the Rural England Prosperity Fund, which is a top-up of the UKSPF and aims to support small business and community infrastructure specifically in rural areas.

Final approval for this element of funding is expected in the New Year, with funded programmes to commence in April 2023.



## Real Christmas trees are being collected

Our waste and recycling crews will be collecting real Christmas trees between 9 and 20 January.



Residents in the Daventry and South Northants areas should put real Christmas trees out on the day that garden waste is due to be collected in their area. You do not need to be a garden waste service subscriber to take advantage of this service.

In the Northampton area, real trees should be put out next to recycling bins, and those on sack collections can present trees beside their recycling boxes and green sacks on their collection day.

People are asked to ensure that all decorations are removed, and that any trees over 6ft tall are cut in half, so they will fit into the lorries safely.

Garden waste subscribers are also reminded that the service will resume from the week beginning 6 January, following the Christmas break.

# Fresh campaign to promote debate not hate

As local councils, we are at the centre of local democracy, and I am sure all of my fellow councillors at Town and Parish Councils across West Northamptonshire will agree - it is a privilege and responsibility to be elected to public office.

As you will be aware, the vulnerability of elected representatives has been at the forefront of the political sphere in recent years with high profile incidents like the murders of Jo Cox MP and Sir David Amess MP.

The most recent Local Government Association Councillor Census revealed 7 in 10 councillors reported experiencing abuse and intimidation within the last 12 months and one in 10 experienced abuse frequently.

Rights to object and constructive challenge are both key components of democracy, and on the whole we receive fantastic levels of support from our communities.

However, it cannot be ignored that increasing levels of toxicity in public and political discourse is having a detrimental impact of local democracy and that prevention, support and responses to abuse and intimidation of local politicians must improve to ensure councillors feel safe and able to continue representing their residents.

That is why I was very pleased recently [to add my signature to the Local Government Association's Debate Not Hate campaign](#)

This campaign aims to raise public awareness of the role of councillors in local communities, encourage healthy debate and improve the response to and support those in public life facing abuse and intimidation.

By signing up to it, we agree to challenge the normalisation of abuse against councillors and officers and uphold exemplary standards of public and political debate in all it does.

# Strong demand for electric vehicle charge point



An electric vehicle charge point installed in Welford is experiencing a strong increase in demand.

In the last three months the unit charged more than twice the number of vehicles it charged in its first three months of operation.

It was installed in West Street in July as part of our Council's ongoing work to support more sustainable modes of transport.
